# **Connection to College Mission**

The primary mission of the Cerro Coso Community College Child Development Centers (CDC's) is to serve the children, families, college students, faculty staff and community members in the areas of Ridgecrest and California City with exemplary child development centers. The centers prioritize meeting the needs of the diverse population of Cerro Coso families with the greatest need. The CDC serves as a lab school for students in the Child Development and other programs to observe models based on current child development research and theories in action, with hands on experience. We accomplish this mission by providing high quality, professional care and education in a safe, healthy, nurturing, active learning environment, along with extensive family engagement and collaboration to ensure holistic support.

# Report on Improvements Made and Gaps Identified in the Prior Year

## **Student Equity**

The center continues to hire student workers from diverse backgrounds.

The CDC currently has 16.49% of children enrolled with an IEP/IFSP.

62.22% of children enrolled at the CDC-IWV campus have one or more parent/guardians currently enrolled at Cerro Coso Community College.

100% of children enrolled are under 100% of the 2021 State Median Income level (SMI) from the CA Department of Finance (DOF).

38% of children enrolled at the CDC's are of Hispanic ethnicity. IWV CDC has 46% and Cal City CDC has 24%.

Children enrolled at the centers identify in the following racial categories:

American Indian or Alaskan Native- 11%

Black or African American-38%

Native Hawaiian or Other Pacific Islander- 2%

Asian -4%

White -61%

## **Evaluate Resource Needs**

#### **Facilities**

During periods of rain, the front walkway of the IWV center floods making the only accessible entry point the stairs (which themselves pool water). The walkway is in need of adequate drainage to reduce the safety hazards and ADA compliance for individuals who may not be able to use the stairs.

The IWV Child Development Center Parking sign is low to the ground and hard to see. It is easily missed which leads to community parking when attending events held in the desert such as track meets.

Heather Ave. site needs evacuation plans and evacuation meeting spot signage.

Counter tops and laminate windowsills throughout the IWV CDC are in need of repair/replacement.

A chemical dispenser needs to be installed at the Cal City site. Currently staff mix all chemicals by hand which is not always the accurate water to chemical mix.

Room A needs ceiling tile (that was damaged from rain) replaced.

The carpet at the Heather Ave. site in Cal City needs to be replaced.

The locks at the Heather Ave. site in Cal City need to be rekeyed.
